**FESTIVAL PROFILE:** As a celebration of the artistic and cultural heritage of our community, the first Woodville Deer & Wildlife Festival of 2008 saw more than 3,000 people in attendance. This year, we anticipate a crowd of at least 5,000.

In June 2009, our festival won Mississippi Main Street's highest honor, "Best Special Event" among the 53 Main Street communities in the state. This year's festival is marketed via radio, regional publications, Internet, direct mail, and a booth at Mississippi Wildlife Federation's Wildlife Extravaganza in August; Children's activities include Pumpkin Patch, Clothesline Art, and Animal Face Painting, Laser Gun Shoot, Youth Archery Tournament, 4-H Nature Art Contest; Fishing Derby for Kids, Mississippi Museum of Natural Science live snakes, as well as live music from regional musicians all day long.

**LOCATION:** The Woodville Deer & Wildlife Festival will be held in downtown Woodville, Mississippi on the Courthouse Square. We invite you to join artist demonstrators, arts & crafts vendors, fine artists, musicians, and food vendors to celebrate the heritage of our community.

### **ALL VENDORS MUST STAY FOR THE ENTIRE EVENT!!!!**

Approved Trade Vendor booths **related to hunting, fishing, and other wildlife and outdoor activities** are offered at the following prices, until space runs out in the designated Festival area:

\$75	10'X10' space
\$150	10'x 20' space
\$300	20'X20' space

Upon arrival, all approved Trade Vendors will be given a site location map showing where they have been assigned. The Trade Vendor booths will open at 10 a.m. and **close no earlier than 5 p.m.** Vendors will be expected to set up by 8:00 a.m. and have vehicles and trailers moved to designated parking areas no later than 9:00 a.m. on Saturday, October 8, 2011. *No vehicles are allowed into Festival area after 9:00 a.m. and before 5:00 p.m. All vendors are expected to leave their space clean and free of trash.*

### **APPLICATION DEADLINE: September 15, 2011**

Check out will take place between 4:30 and 5:00 at which time Festival personnel will collect **Mississippi sales tax (7% of sales)** in the envelopes provided. Under the new sales tax laws, Woodville/Wilkinson County Main Street Association, Inc. is required to collect your sales tax; vendors no longer have the option of mailing it in themselves, **even if you have a retail business!** We accept cash; if writing a check, please make it payable to the Woodville/Wilkinson County Main Street Association, Inc.

All space is outdoors; festival will take place rain or shine. If a vendor uses a tent, it must be secured with sandbags; guy wires and stakes in the ground are not permitted because of safety and because festival takes place on concrete.

***No T-shirts, food items, or beverages may be sold. Main Street's fund raising is based on T-shirt and beverage sales; these proceeds are used to match grants to promote and improve the community.***
